

Domestic Fundamentals:

- Most of the key edible oil markets remained closed and no trade was reported followed by the Lok Sabha poll-general elections Thursday.
- Mostly steady sentiments witnessed in edible oils in various markets where the trade happened.
- BMD CPO ended higher while soy in e- CBOT is trading firm Thursday.
- Coconut oil featured gains at Kangayan market due to lean season, coconut crop damage and lower arrivals from the
- Indian Government revised tariff value on CPO to USD 935 per tons from USD 965/T, RBD palmolein to USD 982/T from USD 1015/T and crude soy oil degummed to USD 961/T from USD 985/T. Indian buyers purchase 97,900 tons of crude sunflower oil majorly from Ukraine during March. While, India imported 5.18 lakh tons of crude sunflower oil in Nov.-March 2013/14, up 23 percent from same period of the last year SEA of India.
- Edible oil basket is expected to feature steady to firm tone in the near-term. While, higher world soybean output projections from last year and consolidation in the international oil and fats market may cap the gains.

International Market Fundamentals:

Malaysian palm oil futures witnessed gains on Thursday, tracking strength in CBOT soybean. However, in expectations
of good demand ahead of the Muslim holy month of Ramadan in late June limit the excessive losses. Exports of
Malaysian palm oil products during April 1-20 fell 5.9 percent to 722,170 tonnes from the 767,785 tonnes shipped
during March 1-20, cargo surveyor Intertek Testing Services.

Outlook: Edible oil basket is expected to feature steady to firm tone in the near-term.
