

Domestic Fundamentals:

Edible oil basket traded sideways at various markets. Sunflower oil, Groundnut oil and Mustard oil market traded with steady sentiments on Thursday. While, Soy oil and Palm oil market closed with steady tone for the day.

Stock limit on oils and oilseeds removed

The central government has released the statement to discontinue the stock limits on edible oils and oilseeds beyond 31.12.2022 which was under the licensing requirements, stock limits and movement restrictions on specified foodstuffs order,2016 that was up to 31.12.2022.

Soybean oil

- In the Domestic market, the Soy oil market traded with steady sentiments.
- CBOT Soy oil most active 'March' contract traded sideways for the day due to continued dry conditions in Argentina.
- Rising crude oil prices may underpin Soy oil prices as US's crude oil inventory drops down.

Palm oil

- Domestic prices traded steady for the day due to increased rival oil prices.
- Palm oil prices expected to shoot up as Indonesia, its top producer is going to tighten export rules for the oil from 1st January, that will further lead to lesser shipments overseas for every tonne sold domestically, to ensure sufficient domestic supply.
- The Malaysian palm oil exports in December fell by 0.8% to 1,262,147 tonnes from 1,272,721 tonnes during the month of November.
- The benchmark palm oil contract for March delivery on the Bursa Malaysia Derivatives exchange surged by 7% or 274 ringgit to 4,104 ringgit a tonne, and made a 3-week high and its biggest one-day jump in three months, as China, the major market of palm eased its border entry rules.
- Floods across several states in Malaysia is hampering with palm oil production and logistics, which is likely to support palm oil prices.

Mustard oil

- Mustard oil prices traded steady for the day. Demand is improving with fall in temperature and cool weather.
- Mustard seed crushing is still in disparity. However, if prices of oil and meal rise gradually, crushing may turn to parity.

Outlook: Edible oil basket is expected to trade with bullish sentiments with upward sentiment for the week.
