- Oscillator RSI is moving in the neutral zone.

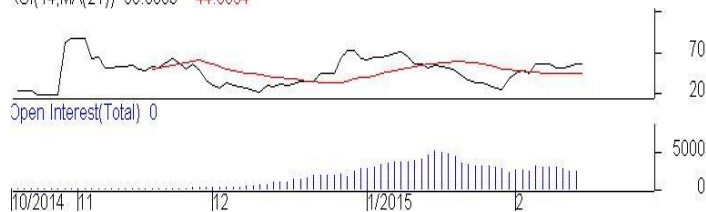
The CPO prices are likely to feature range bound today.
