

## **Wheat Domestic Fundamentals:**

**Market participants** opine that wheat FAQ varieties would trade slightly higher in the short to medium term while premium grade would continue to trade firm. Wheat is being traded in the range of Rs 1560 to Rs 1670 per qtl., depending upon sourcing place and quality of the seed.

**Wheat import during the week ending 4<sup>th</sup> Oct - was registered** at 25816.39 tonne at an average CioF quote of \$258.96 per tonne. As parity is not in favour of India, export volume is unlikely to increase in the coming weeks. There is no export in last week ending 4<sup>th</sup> October. Wheat has been imported from Australia and offloaded at Cochin port.

Wheat stock in central pool was registered at 336.65 lakh tonne as on 16.09.2015. Stock in transit was reported at around 3.46 lakh tonne while wheat lying in mandis was registered at 0.35 lakh tonne. As on first October India requires 175.20 lakh tonne as buffer stock and 30 lakh tonne as reserve stock. In Sept 2014 central pool stock was registered at 351.72 lakh tonne. It is 1.98 percent lower than the available stock in Sept, 2014

Agricultural Statistics Division, Directorate of Economics & Statistics (DES) has released First Adv. Estimate for kharif crop for 2015-16 on 16th Sept,2015. Production target for wheat in Rabi has been set at 94.75 lakh tonne. In fourth adv. estimate it has revised wheat production estimate for 2014-15 to 90.78 lakh tonne. Notably, India has produced 95.85 million tonne wheat in 2013-14.

**Total wheat procurement was registered at 280.88 lakh tonne** as on 14.07.2015 as against 271.66 lakh tonne during same period last year. Punjab has contributed 103.44 lakh tonne so far, followed by Haryana 67.78 lakh tonne. M.P. contribution stands at around 73.09 lakh tonne. Rajasthan has procured only13.0 lakh tonne. Overall procurement is up by 3.39 percent this year.

Wheat cash market is expected to stay steady to slightly firm in the near to medium term due to seasonal factors and hope for MSP hike for the next MY. The CACP has recommended Rs 75 per qtl hike in wheat MSP to Rs 1525 per qtl. for Next MY. Supply side may shrink slightly. However, ample stock available with govt and its regular release would limit any unexpected spike. Premium grade would continue to rule firm as expected. International Market Update:

Wheat FoB quotes in Russia improved around \$5 per tonne in anticipation of wheat export tax cut and govt 's plan to procure wheat at higher price. Decision on tax cut is expected in the first week of Oct. Wheat having 12.5 percent protein content quoted at \$187 per tonne free-on-board (FOB) at the end of last week, up \$5 from a week earlier. Currently, export tax is set at 50 percent of the customs price minus 5,500 roubles (\$83) per tonne, but not less than 50 roubles a Ton. Now limit may be raised from 5500 to 6500 rouble per ton.

Iran has cancelled import duties imposed in the month of July this year on wheat. Notably, Iran govt. had imposed wheat import duty @ \$50 per tonne which made import totally unfeasible. Import duty has been lifted off despite repeated statements that Iran has sufficient stock and there is no need of any import this year.

Russia exported 6 million tonne wheat during 1st July to 18, sept-2015. Wheat export volume has decreased 23 percent in comparison to last year. Domestic price for third grade wheat is being quoted at \$154 per tonne.

With favourable weather condition for standing crop of wheat in Australia market analysts have started talking higher than expected production this year. As per the latest update by ABARE Australi may enjoy 25.2 MMT wheat production this year and export 1MMT more than normal expectation of 16.5 MMT in 2015-16(starting from July to June) Higher export expectation has surfaced ground despite ample EU and Black Sea Region Crop.

Domestic market Outlook: Wheat cash market is likely to stay steady to slightly firm.
