

Wheat Domestic Fundamentals:

All India average wheat price decreased by 0.50 percent to Rs 1783.52 per qtl. during the week ended 27th August-2016..Wheat average price was ruling at Rs 1792.59 per qtl in the fourth week of August-2015..All India average price is higher by 8.11 % in comparison to price (Rs 1649.59 per qtl.) registered in the fourth week of August, 2015. Overall trend in cash market is expected to remain steady to slightly weak as govt. may revise wheat import duty from 25% to 10 % in Sept.-2016.It would pressurize inner tone in the market.

Wheat import starts increasing now. India has imported 74,300 tonne wheat during week ended 21st Aug-2016. It had imported 60458 tonne wheat previous week. Wheat has been imported from Australia, France and Ukraine at an average CiF of \$240.3,\$202.95 &192.99 per tonne respectively. Wheat import in this marketing year till 21 Aug-2016 has reached at 215768 tonne. Out of total import Australia has contributed 69755 toone, Ukraine 's share has been 11703 tonne while France has offloaded 58100 tonne so far. Import flow is likely to continue in coming weeks. As per market sources around 12 lakh tonne import deals have been struck so far for delivery till October-2016.

India exported only 21370.44 tonne wheat in current marketing year till 21st Aug-2016 at an average FoB of \$325.52 per tonne. Export pace has been negligible due to higher domestic price and lower crop size. India exported only 538.43 tonne wheat during week ending 21st Augat an average FoB of \$368.48 per tonne. It is 17.67 % higher than previo us week. On an average India exports around 450 to 500 Tonne wheat per week, that is much below than normal expectation. Export volume would likely to remain at lower level due to prevailing wide disparity.

With a aim to curb hoarding by bulk buyers/consumers FCl has restricted upper limit of wheat quantity from 5000 T to 500 tonne only in a single e-auction under OMSS. There is a apprehension that hoarding by big players/consumers may influence wheat price in open market. Wheat price in major bench mark market has increased in the range of 15 to 18 percent from April-2016. It has started affecting prices for wheat products now. This year stock with Govt is lower due to lower crop and procurement size and it may touch eight years low by March-2017 end.

Wheat stock in central pool is almost 25.28% lower than stock registered in Aug-2015. As on 1st August-2016 wheat stock in central pool was registered at 268.79 lakh tonne. It was 301 .81 lakh tonne in July-2016. Major portion of wheat stock is available in north zone where 202 lakh tonne wheat was registered in stock. South zone has 54.18 lakh tonne wheat. North zone includes Haryana, Punjab and Rajasthan while south zone includes Gujarat, Maharashtra, M.P. and Chhatisgarh.

International Market Update:

IGC has revised wheat production projection up by 8MMT from735 MMT to 743 MMT on 25th, Aug-2016 for crop year2016-17. According to IGC global wheat production for 2016-17may touch 743 MMT against 736 forecast for 2015-16. Soft Wheat export(Outside EU) from France is expected to decline considerably from 12.5(last Year to 4.8MMT in 2016-17.Wheat production in France has declined by 28 % this year due to bad weather. Its soft wheat export in EU too is likely to decline7.5 to 6.5 MMT this year. Thus total export may decline by 40 % to 11.5 MMT .Wheat production in France is expected to decline from40.9 to 29.5 MMT this year.

Farmers in Russia/Ukraine have started retaining wheat having higher protein content as they have analysed the emerging scenario in global wheat market. Around 30 % crop loss in France and buyers turning to Russia/Ukraine for sourcing wheat have encouraged local price in black sea region. In Ukraine, prices for wheat with 12.5 percent protein content rose 1.2 percent from a week earlier to \$172.5 a ton. It is \$166 per tonne for wheat having 11.5 % protein content. Wheat price in Black Sea Region Is expected to hover in the range of \$\$165 to \$175 per tonne in coming weeks.

Domestic market Outlook: Wheat cash market is likely to trade weak in the near term.
